  - (ii) History has recorded the American Revolution, the Industrial Revolution, and the Sexual Revolution. Today we are witnessing a revolution in the way we receive information. What do you think will be the next great revolution, and what will be its impact on you and your society?
  - (iii) Community service can be a valuable part of the college experience. If you were to devote one year of service to a volunteer project, what would it be, and what would you hope to accomplish?
